You have to download the specific accreditation form from the website and send it directly to fia_erc_accreditations@eurosport.com and prensa@rallyislascanarias.com.

You have to fill up the form with your personal details and, for the tv media, have to explain the reason why you are going to recording during the event. Every request have to say if they are going to recording for a TV channel, personal use, for a team or for a driver.

Websites that want to recording during the event and want to be accreditate, have to follow this procedure.

The deadline to receive this forms will be determinated by Eurosport Events. Those arriving after that date will not be considered. Each authorized media will receive an Eurosport confirmation letter that must be presented in the press room in order to receive the accreditation.
